## Written Oath and Inquiry Consent Form Regarding One's Declaration and Guarantee of Lack of Involvement with Antisocial Forces

- 1 I, the undersigned (individual / corporation / organization), hereby declare and guarantee that none of the following forms of antisocial forces are applicable to me at present nor will they be applicable to me at any point in the future
- (1) A violent crime organization (boryokudan)
- (2) A member of a violent gang or organization or been a member of such an organization within the past five years
- (3) An associate member of a violent crime organization
- (4) A company associated or affiliated with a violent crime organization
- (5) An organization that participates in corporate racketeering, etc. (sokaiya)
- (6) An organization that participates in political racketeering, etc.
- (7) An organized crime syndicate, etc.
- (8) Any other organization or individual that is equivalent to the descriptions listed within the previous items
- 2 I, the undersigned (individual / corporation / organization), hereby declare and guarantee that the antisocial forces listed in the previous clause as well as any of the following items do not apply to me at present and shall not apply to me at any point in the future.
- (1) My administration/management is under the control of antisocial forces1.
- (2) Antisocial forces have any substantial involvement with my business
- (3) Those in my managerial staff or advisors are part of antisocial forces, commission or consult with antisocial forces for the purpose of conflict resolution, or am engaged in any other relationship in which I enlist the assistance of antisocial forces
- (4) Provide funds and/or services, etc. towards antisocial forces
- (5) Any person in a managerial position or who is substantially involved with my administration/management maintains relationship(s) with antisocial forces in a way that would be viewed as worthy of censure within society
- 3 I, the undersigned (individual / corporation / organization), declare and guarantee that I, whether it be personally or through a third party, shall not partake in any activities

that apply to the following.

- (1) Acts of violent extortion or intimidation
- (2) Making any unjust demands that exceed my responsibility in the law
- (3) Partaking in any threatening behavior or undertaking acts of violence in dealing with customers or other companies
- (4) Spreading rumors and utilizing false schemes or influence to undermine the reputation of your company, or undertaking any activities to debilitate the operations of your company
- (5) Any other activities equivalent to the actions described in the previous items
- 4 I, the undersigned (individual / corporation / organization), pledge that I will not raise any objection in the event of my rejection of my entrance as a member or the removal of my membership status in the Nishiyama-cho Board of Commerce and Industry if it is proven that I do not fulfill any of the clauses listed above, or if that this declaration and guarantee are proven to be false. In the event that there are any losses incurred from such an event, I shall take full responsibility for said damages.

Additionally, I agree that the Nishiyama-cho Board of Commerce and Industry may make inquiries to specialized agencies (the Niigata Prefectural Police Department / The Niigata Prefectural Center for the Elimination of Boryokudan Public Service Foundation) in order to prove the validity of the applicability with any of the clauses listed above.
